1. Minutes of the 166th Commission meeting

4. Commissioner Report

4.1 Commissioner Milton Kerr reported on his attendance at the British-Irish Intergovernmental Secretariat event on 22 January.

5. Director's Report

- 5.1 Commissioners discussed the Director's Report.
- 5.2 The Director reported that the NIO had approved the recent business case regarding the new lease.
- 5.3 The Director reported on upcoming training she will be delivering in Vienna with the Northern Ireland Ombudsman on the Human Rights Manual for the work of Ombudsman.
- 5.4 The Director reported on training she has given to the Probation Board for Northern Ireland on a human rights based approach to their work.
- 5.5 Commissioners discussed the Commonwealth Forum Chair and the funds needed to fulfil the position. There

- was agreement that this would be a good opportunity for the Commission if funding is forthcoming.
- 5.6 The Finance and Administration Manager reported the finance report and an issue of an outside attempted credit card fraud. This has been reported to the NIO as our sponsor department and will be reported to the Audit and Risk Committee.
- 5.7 The Director reported on the recruitment of a Researcher at SO (Permanent) and an Assistant Researcher at EO1 (Temporary).

6. Business Plan update

6.1 Commissioners agreed that as this was the first opportunity to look at the Business plan that it would be discussed in more detail at the Commissioner away day and it would be signed off at the February meeting. The broad thrust of the document was agreed subject to a number of amendments.

8. Human Rights Inquiry Chapters – Introduction and Quality

- 8.1 Commissioners discussed the Introduction to the Human Rights Inquiry. A number of substantive points were made including the need for more case studies, using a broader range of waiting time statistics, further detail on the findings on nursing home transfers to emergency departments and a look at further detail on comparison of thrust policies if possible.
- 8.2 Commissioners discussed the Quality chapter to the Human Rights Inquiry.
- 8.3 Commissioners agreed that following discussion the chapter on quality would be amended and copied to the Commissioners. The introduction chapter would be amended once other chapters are completed.

9. Legal Assistance Request

- 9.1 Commissioners received a briefing on a request for legal assistance (HRC167.5).
- 9.2 Commissioners discussed the detail of the request.
- 9.3 Commissioners agreed by majority that the request for assistance would not be granted. The Commissioners also agreed that a meeting would be sought with the Director of Public Prosecution Service. Commissioner Marion Reynolds dissented from the decision to not grant legal assistance.

10. Bill of Rights

10.1 Commissioners noted with disappointment the reference in the Stormont House Agreement that there is not at present consensus on a Bill of Rights and also the update from Commissioner John Corey on work to advance the Commission's action plan on the issue.

11. Any other business

- 11.1 Commissioners were updated on the new timescale for the consultation process which has moved from 12 weeks to 8 weeks. Commissioners agreed to discuss the implications of this further.
- 11.2 The agenda for the community engagement event to Carrickfergus was shared with Commissioners.
